INSTRUCTIONS FOR SERVICE BY PUBLICATION

If you do not know where the Respondent resides, you must serve the Respondent by publishing a notice in the legal organ for the county of the respondent's last known address. The legal organ is the newspaper that publishes legal notice for a particular county.

To do this you must complete the following steps:

- 1. Prepare your petition. Make sure that you state in your petition that it is being served by publication.
 - 2. Make a diligent effort to locate Respondent.
- 3. Complete the Affidavit of diligent search form indicating you have made a diligent effort to locate Respondent.
 - 4. Complete the Notice of Publication form.
- 5. Complete the top portion of the Order for Service by Publication. The Judge will sign the bottom portion if the Order is granted. In addition to the normal filing fee, you must also pay a publication fee. Please check with the Clerk of the Superior Court to get the fee amount.
